Regulations

- Pre entry events \$15 per class. Entries close Saturday 28th January at 12 noon sharp to the EVENT SECRETARY.
- Late Entries and Entries on the Day available at \$30 per class from the EVENT SECRETARY. Float/Truck Passes at Gate.
- ANY horse may enter ANY competition event EXCEPT qualified events.
- All competitors must supply their own number in a suitable number holder (numeral allocated by Event Secretary)
- Exhibitors must be financial members of;
 - Any registered Hunt Club with the DPI or
 - Equestrienne Victoria (EV) plus join as \$10 day member of YGLHC or
 - Join 'Yarra Glen & Lilydale Hunt Club' as a Single Event Member and pay \$20.
- Proof of Hunt Club membership must be supplied prior to event start or competitors will have to join as Event Member.
- Werribee Park Attendance Levy at \$16 per horse per day.
- Werribee Park Gate Pass at \$30 per Exhibitor Animal Transport Vehicle Only
- Car access via Zoo gate ONLY and transfer via mini bus. Pedestrian prices for adults, children pensioners families at gate.
- Cancellation of entries after 28th January and up until 14th February incur \$50 processing fee and must include vet or medical certificate. No refund or cancellation from the 14th February.
- Horses in Qualified events must supply signed card or letter from Club President or Master prior to event start. Qualification is two hunts within 2010 or 2011 seasons.
- Grand Champion Qualified Hunter must be Qualified and ridden by Hunt Club member not Single Event or EV members.
- Novice not to have won similar event at Barastoc or Melbourne Royal Show.
- Junior and Child classes all riders under 18 years, evidence may be required.
- All Pair and Trio events may include any club, height, colour, age or gender combination. Points will be earned for each Club and each horse in combo classes toward Grand Champions & Club High Point.
- All listed and unlisted rules subject to any reasonable change by the EVENT SECRETARY and GROUND JURY.
- "The Hunt Clubs Marquee" will be erected as a shared facility, a BBQ hotplate will be supplied. All friends of Hunting are welcome under a BYO and co contribution. Please contact the SPONSORSHIP MANGER if you or your club can help.

In consideration for being permitted to participate in any way in horse sport activities, I, the undersigned, understand, acknowledge and accept that: Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt. There is a significant risk that serious INJURY or DEATH may result from horse sport activities. I knowingly and freely assume all such risks, both known and unknown, and I voluntarily PARTICIPATE at my OWN RISK and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activities and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during any horse sports activities.

I agree to follow the directions of any event organizer or official and that any misconduct or refusal by me to follow any direction of any organizer or official can result in the CANCELLATION of my participation in the activities and my immediate removal from my horse NO MATTER where that may occur. I understand that any such non-compliance may result in injury, death and/or permanent disability as a result of my failure to comply. I agree to wear a helmet at all times whilst participating in the sport where this is required under the relevant EA and FEI rules and regulations, and agree that I am solely responsible for ensuring that whilst participating I wear a suitable helmet at all times, and take sole responsibility for my actions.

I understand that due to diseases such as equine influenza, the Victorian Department of Primary Industries, or other State or Commonwealth government body, may restrict or prevent the movement of horses, vehicles and personnel for a period of time ("Standstill"). I acknowledge and agree that a Standstill is a risk of participating in all and any events held at/by the Yarra Glen & Lilydale Hunt Club Inc. I acknowledge and agree that I will pay any costs or expenses incurred by DPI, EA or the Committee for or on behalf of my horse or as a result of a Standstill.

In consideration of EA and the Committee accepting my application to participate in the Event, I, to the extent permitted by law:

- (a) Release and will release EA and the Committee from all Claims that I may have or may have had but for this release arising from or in connection with a Standstill and/or my participation in the Event; and
- (b) Indemnify and will keep indemnified EA and the Committee in respect of any Claim by any person arising as a result of or in connection with a Standstill and/or my participation in the Event.

In this registration form, references to:

"Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising.

"EA" means Equestrian Australia or their nominated State Branch and includes its directors, officers, servants or agents.

"Committee" means the organizer of the event, whether an individual, unincorporated group, association or company, and, where the context permits, includes their directors, officers, members, servants or agents.
